Exam Fee Change

HPTC has resisted a fee adjustment for several years, primarily due to some financial savings as the result of the pandemic. As business practices return to normal post pandemic the pressures of expenses on our core business continues to increase incrementally.



As a result of increased overhead expenses, the main RT examination product will be increasing to \$949 for the January 2024 and subsequent examinations.

Candidates should plan accordingly, and Respiratory Therapy programs update any relevant external funding agencies of these planned changes.
